## FOUR NEW TRUSTEES JOIN FOUNDATION BOARD

Four new trustees have been named to three-year terms on the Board of The Catholic Foundation. They are: O.D. (Dan) Cruse, who retired from the executive search consulting firm, Spencer Stuart, where he served as Vice Chairman of the firm and Partner in Charge of the Dallas office; John R. Kraft, who established the State Farm Insurance Agency in Plano; Victoria P. Lattner, a Certified Public Accountant who previously served as Vice President of Finance at Southwest Media Corporation; and David M. Rosenberg, a senior partner in the law firm of Thompson & Knight, L.L.P.

In addition to their professional responsibilities, each new trustee has also been active in his or her parish life and the Catholic schools, and has taken leadership roles in a number of civic causes and organizations, including The Crystal Charity Ball, Catholic Charities, the Dallas Symphony Orchestra, Ronald McDonald House, ChildCareGroup, the Plano Chamber of Commerce, and the University of Dallas.

New trustee Dan Cruse says his admiration and respect for founding trustees Ed Maher and Tom Unis, among others, inspires his service to the Diocese. He considers the Board's work "a gigantic responsibility we need to live up to and pay close attention to."

John Kraft brings a special interest in education in the Diocese to the table. "I look

forward to representing an organization that has a history of providing the cornerstone funding for schools like John Paul II, and making a difference on a daily basis for schools like Our Lady of Perpetual Help." Of his role on the Board he says, "I hope to use my sales and marketing background to increase the awareness and value of The Catholic Foundation in the Plano area."

Board Chairman Robin P. Hartmann welcomed the new members, noting "The Foundation benefits, as do the people we serve, from the diverse expertise and experience of our trustees. We are most grateful for these four new trustees and their commitment to the people and the institutions of the Diocese of Dallas and the charitable intentions of our donors."

stewards of our donors' philanthropic visions, our funds are invested very prudently.

In addition, we have been blessed by an increase in contributions to the Foundation this past year, in part thanks to today's faithful donors and in part as a result of generous estate planning developed years ago.

Still, the projected need for funding in the Diocese outpaces the Foundation's grant resources almost two-to-one. Despite an awareness that these needs are greater than ever, prospective donors with charitable intentions might not be prompted to act right now, given the level of economic uncertainty. This is when confidence and trust in the Foundation come into play again, and where the Foundation's ability to help donors create meaningful charitable legacies using a full range of philanthropic and estate planning tools can make a real difference in our ability to continue to serve the community at a consistent level.

## TAKING CARE OF BUSINESS

When Charles (Chuck) Kobdich and his wife, Ellen, decided it was time to update their wills recently, they met with an estate lawyer, a financial planner, and Michael George of The Catholic Foundation.

Their objective was to create an estate plan that would take care of their heirs and effect their philanthropic goals – without compromising either. “It's an estate plan,” says Mr. Kobdich, a partner in the law firm McCall, Parkhurst & Horton L.L.P., “that happens to have a charitable aspect to it. It's not just a charitable plan. That's why you need your lawyer and financial planner to work with the Foundation.”

For Chuck and Ellen Kobdich, the plan involves using the assets of their estate to create two new trusts. New life insurance policies were used to establish a separate asset replacement trust. Existing assets went into a Charitable Remainder Unitrust at The

Catholic Foundation. Upon the death of the second of the spouses, the first trust matures and proceeds from the life insurance policies benefit the three Kobdich children. At this same time, (when the second spouse dies), the Charitable Remainder Unitrust – which is also intended to provide post-retirement income to the couple – matures into a fund which the Foundation will primarily use to support four specific charities: Catholic schools, the Notre Dame School of Dallas, Fisher House (which provides support to military families), and Sacred Heart Catholic Church in Mt. Vernon, Texas.

“We are all going to die sometime,” Chuck Kobdich says. “The question is what happens

to your assets at that time. Creating an estate plan that fulfills your charitable desires and provides for your heirs takes some work. But when it's all done, you feel really good. You've taken care of business.” 🐟

# A LIGHT On

## TEACHERS WITH “HEART” WIN \$5000 AWARDS

*“She is a dedicated, kind, devoted Christian role model for our students.”*

While this one sentence was written to recommend one specific nominee, it applies equally to each of the three winners of \$5,000 grants from the Foundation’s Work of Heart program this year, indeed to most of the program’s nominees. That’s what the Work of Heart is all about.

Here’s more of what was written about each of the winners:

*“Mrs. Clem does unexpected acts of kindness.”*

*“Mrs. Perry is an inspiration whether she wins this award or not, but knowing that she knows we care about her would be a wonderful thing. She deserves the accolades.”*

*“I admire Miss Noller for being a young person in our society, giving the gift of her time to infants, toddlers, and teenagers.”*

The Work of Heart Award is a unique program created in partnership with The Catholic Foundation by an anonymous donor who sought to recognize the teachers, administrators and staff of Catholic lower, middle, and high schools in the Diocese of Dallas with grants ranging from \$500 to \$5,000 for exemplary service. This year, with the family’s continued support along with a grant from The Catholic Foundation’s Unrestricted Fund, recognition of Catholic school employees can be continued with \$100,000 in awards.

The three largest awards (\$5,000 each) were given to Christina Clem, principal of St. Elizabeth of Hungary Catholic School; Vanessa Perry, first grade teacher, St. Patrick School in Dallas; and Joanne Noller, teacher and director of Bishop Dunne Catholic School’s Early Childhood Center. In each case, their job titles are, however, just part of the story of their outstanding work in the schools.

Christina Clem, for example, is considered an “angel” by the many families in her school she has helped during hard times. They write of her

daily prayers and her tenacious assistance with finances, food, scholarship support, and keeping their children in Catholic schools. She has also been singled out for advancing technology at St. Elizabeth, for building community within the school population with grade-level pot-luck suppers, and for her thoughtful, caring ways with students and staff alike.

Vanessa Perry isn’t just a first grade teacher, either. She is every child’s favorite teacher, a woman who has brought extraordinary energy and good cheer into the classroom every day for years. According to the parents of St. Patrick

School, she has consistently taught their children patience, humor, a love of reading, the dignity of differences, and her deep Catholic faith – remarkable gifts made even more compelling by the recent, unexpected death of her husband.

Joanna Noller already has two jobs at Bishop Dunne – director of the school’s Early Childhood Center and 6th grade “World Cultures” teacher – but she’s always taking on something more. She mentors and trains other teachers and child care providers; she opens the childcare center to teachers’ children during after-school meetings; and she coaches two girls’ volleyball teams. In doing so, her colleagues say, she is an exemplary role model, living out her dream of teaching Catholic values and making a difference in the lives of others.
